#### **PRIVATE PILOT CERTIFICATE - ASEL:**

FAA minimum requirement is 40 hours, including 20 dual and 10 solo. Individual training times vary greatly, depending upon a number of factors, and the FAA website says most people require 60 to 75 hours of training. These figures are for 50 hours, including 35 dual and 15 solo.

**INSTRUMENT - AIRPLANE RATING** (Assumes a pilot meets ACS standards in all Private Pilot tasks/maneuvers): FAA requires a minimum of 50 hours cross-country as Pilot in Command, and 40 hours of instrument time, including 15

hours of instrument instruction. These figures are for maximum allowable time in our Advanced Aviation Training Device (AATD) and 65 hours in a Cessna 172, to include the cross-country Pilot in Command and instrument time requirements. Students with cross-country PIC time over 5 hours will require that much less C-172 time (up to 30 hours).

#### **COMMERCIAL PILOT CERTIFICATE - ASEL:**

FAA requires at least 250 hours, and 20 hours of instruction for the commercial license, with at least 10 in a complex airplane or Technically Advanced Airplane (TAA). At this point you have 115 hours of Cessna 172 and 23 hours of AATD time, so you need at least 112 more hours. These figures are for 80 hours in the Cessna 172, 15 hours in the AATD, and 20 hours instruction in a Technically Advanced Airplane.
